If using a Justice Court Judge, the marriage application needs to be turned into the Clerk's office in advance and before contacting Justice Court for an appointment.

The marriage application needs to be <u>returned in advance</u>, and BOTH parties will need to sign all final paper work before the wedding date, with an I-D, as with a driver's license, or passport, or military, etc., before the license may be issued.
