GENERAL LIABILITY:

ADDITIONAL INSURED REQUIRED: LAUDERDALE COUNTY, MISSISSIPPI & LAUDERDALE COUNTY BOARD OF SUPERVISORS

A SECURITY DEPOSIT FEE OF \$150 FOR BUILDING AND GROUND. AFTER THE PROPERTY HAS BEEN INSPECTED, THE DEPOSIT WILL BE REFUNDED AFTER THE CLAIMS DOCKET IS APPROVED BY THE BOARD OF SUPERVISOR. REFUND COULD TAKE UP TO 30 DAYS. UPON INSPECTION THE DEPOSIT IS REFUNDABLE IF THE BUILDING AND GROUND ARE CLEARED AFTER THE EVENT.
