Each bid must be received in a sealed envelope which is clearly marked in the lower left-hand corner with the **“BID NUMBER – BID NAME”** and the **“DATE OF THE BID OPENING”**. The envelope should also display the **“NAME and ADDRESS OF THE BIDDER”**

From the bids submitted, the Board of Supervisors shall select the most qualified based on price, and other relevant factors, negotiate and enter into a contract, all pursuant to Section 31-7-13, Mississippi Code of 1972, as amended. All proposals offered will be read aloud. All bids will be evaluated by the Lauderdale County Purchasing and Road Manager.
