ADDENDUM NO. 2 - addresses the following:

- a. Systems Description
- b. Updated Drawings
- c. Maintenance Service

Refer to the drawings for clouded revisions.

1. Refer to the specification, Division 27 4116, Part 1, Article H, Section 8 "Systems Description", Paragraph a, add the following paragraphs:
 1. The scope of work includes completely removing existing sound system equipment, controls, cabling, surface-mounted raceway from the site completely.
 2. The contractor shall dispose of existing equipment as directed by the owner.
2. Refer to the drawings, sheet AV3.1.
 1. Revise quantity of loudspeakers for Zone "East Connector" to match the plan (sheet AV1.5).
 2. Add network switch and related components and cabling.
 3. Revise control panel TP RK from a rack-mounted to table-top configuration.
 4. Revise wireless microphone notes and circuiting.
 5. Add new restroom and office loudspeaker zones.
 6. Add AM/FM Antennae and related cabling.
3. Refer to the drawings, sheet AV1.6.
 1. Add detail, "Power Distribution Single Line".
 2. Add detail, "Rack Configuration Detail".
 3. Revised Rack and Distribution Frame Notes.
 4. Revise detail, "MDF Rack Elevation".
 5. Revise detail, "Announcer Booth Enlarged Plan".
 6. Delete detail, "TP RK Rack Panel Elevation".
4. Refer to the drawings, sheet AV1.1. Revised loudspeaker table.
5. Refer to the drawings, sheets AV1.4, AV1.5 for revised loudspeaker plan.
6. Refer to the drawings, sheets AV1.1, AV1.2, AV1.5, AV3.1. Add loudspeakers as shown for restroom and office zones.

7. Refer to the specification, Division 27 4116, Part 1, Article H, Section 20 "Maintenance Service".
Add the following paragraphs:
 1. Revised paragraph 20, a to read as follows: "Provide with bid, a proposal for post-contract, annual, renewable Service and Maintenance Contract. Such contract shall provide the following services:
 2. Add the following sub-paragraphs:
 1. Semi-annual site visits to inspect and service the equipment rack (MDF). The inspection shall include:
 1. Visual inspection, service and repair of cabling and terminations.
 2. Cleaning rack interior.
 3. Inspection and cleaning of all fans.
 4. Inspection and cleaning of rack front.
 5. Inspection and cleaning of all rack vents.
 2. Log in to the DSP/Control system to inspect logs and operational conditions. Ensure that system configuration is operating properly. Review logs for system component failures, alarms, and instances of audio clipping. Make revisions as needed.
 3. Operate system with noise source or program music. Walk all spaces and listen for anomalies, noise, mechanical and acoustical anomalies, tone, and level. Adjust system as necessary.
 4. Report any component failures to the owner. If under warranty, replace in accordance with Part 3 of the specification. If out of warranty, submit proposal for repair.
