BID SPECIFICATIONS: ELECTRO-HYDRAULIC COMBINATION TOOL

- 1. The tool is designed hydraulically activated piston with two equal, opposite blade arms that are symmetrically opened by mechanical joints thereby spreading, squeezing, pulling or cutting objects.
- 2. Electro-hydraulic device does not need to be connected to an external hydraulic source, generation of the required hydraulic pressure takes place within the body of the device by a quick exchange of lithium/ion battery (Milwaukee or DeWalt battery)
- 3. The electro-hydraulic tool is equipped with light to increase visibility under poor lighting conditions, for simplicity, the lighting must be powered by the same Lithium/ion battery that powers the electro-hydraulic tool and not a secondary battery.
- 4. The cylinder of the tool shall be made of anti-corrosive light aluminum alloy for its strength and long life. The body of the tool shall have high impact, non-metallic housing.

- 16. The tool must be NFPA 1936; 2020 Edition Certified and shall be labelled as such bearing the mark of the testing agency.
- 17. The tool shall have an IP protection class rating of 54.
- 18. The tool shall not weigh more than 57 lbs (25.85 kg) including battery.
- 19. The tool shall have a mounting bracket made of steel for the tool.
